**2. HAZARDS IDENTIFICATION**

**Main hazards:** Irritating to eyes. Limited evidence of a carcinogenic effect. May cause sensitisation by skin contact.

**4. FIRST AID MEASURES (SYMPTOMS)**

- Skin contact:** There may be irritation and redness at the site of contact.
- Eye contact:** There may be irritation and redness. The eyes may water profusely.
- Ingestion:** There may be soreness and redness of the mouth and throat. Nausea and stomach pain may occur. There may be vomiting.
- Inhalation:** There may be irritation of the throat with a feeling of tightness in the chest.

**4. FIRST AID MEASURES (ACTION)**

**Skin contact:** Remove all contaminated clothes and footwear immediately unless stuck to skin. Drench the

affected skin with running water for 10 minutes or longer if substance is still on skin. Consult a doctor.

**Eye contact:** Bathe the eye with running water for 15 minutes. Consult a doctor.

**Ingestion:** Wash out mouth with water. Do not induce vomiting. If conscious, give half a litre of water to drink immediately. Consult a doctor.

**Inhalation:** Remove casualty from exposure ensuring one's own safety whilst doing so. Consult a doctor.

#### 5. FIRE-FIGHTING MEASURES

**Extinguishing media:** Suitable extinguishing media for the surrounding fire should be used. Use water spray to cool containers.

**Exposure hazards:** In combustion emits toxic fumes.

**Protection of fire-fighters:** Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.

#### 6. ACCIDENTAL RELEASE MEASURES

**Environmental precautions:** Do not discharge into drains or rivers.

**Clean-up procedures:** Transfer to a closable, labelled salvage container for disposal by an appropriate method.

#### 7. HANDLING AND STORAGE

**Handling requirements:** Avoid direct contact with the substance. Ensure there is sufficient ventilation of the area. Do not handle in a confined space. Avoid the formation or spread of dust in the air.

**Storage conditions:** Store in cool, well ventilated area. Keep container tightly closed.

**Suitable packaging:** Must only be kept in original packaging.
