**2. HAZARDS IDENTIFICATION**

**Main hazards:** Irritating to eyes and skin.

**3. COMPOSITION / INFORMATION ON INGREDIENTS**

**Hazardous ingredients:** METHYL TRIACETOXY SILANE 1-10%  
EINECS: 224-221-9 CAS: 4253-34-3  
[-] R14; [C] R34

**4. FIRST AID MEASURES (SYMPTOMS)**

**Skin contact:** There may be mild irritation at the site of contact.  
**Eye contact:** There may be irritation and redness.  
**Ingestion:** There may be soreness and redness of the mouth and throat.  
**Inhalation:** There may be irritation of the throat with a feeling of tightness in the chest. Drowsiness or mental confusion may occur.

**6. ACCIDENTAL RELEASE MEASURES**
